2. 如需更改身份證明文件類別或編號，必須攜同有關身份證明文件正本親自至研究生院櫃檯遞交申請。 Students who apply to amend the type or number of identification document should submit the application to the School of Graduate Studies Service Counter in person together with the original copy of identification document.
3. 中國內地學生如申請轉換身份證明文件類別，須同時遞交《[聲明書](#)》。 For students from mainland China who apply to change the type of identity card must submit a “[Declaration](#)” together with this application form.
4. 學生如因更改姓名而需要更換校園卡，學生可透過 WeMust 提出更換申請，並繳付校園卡更換手續費(港幣/澳門幣 300 元)，完成後留意領卡通知。 For students who amend their names, application for Replacement of Student Campus Card should be submitted through WeMust, and application fee of HKD/MOP300 should be paid. Please be aware of the collection of Student Campus Card notice after submitting the application.

The change of student status has no retrospective effect on tuition fees and charges.
