Remarks :

- ① Applicants who have color blindness or color weakness cannot be admitted to the program of Bachelor of Traditional Chinese Medicine, Bachelor of Biomedicine, Bachelor of Pharmacy in Chinese Medicine, Bachelor of Arts in Art Design, Bachelor of Fine Arts in Digital Media, Bachelor in Film and Television Production, Bachelor in Acting, Bachelor of Food and Nutritional Sciences and Bachelor of Pharmacy. Applicants who are color blind cannot be admitted to the program of Bachelor of Science.
- ② Applicants of Bachelor of Pharmacy in Chinese Medicine, Bachelor of Pharmacy and Bachelor of Food and Nutritional Sciences must be from the science stream and must have senior high school Chemistry grades or equivalent. Therefore, applicants are required to submit the transcripts of the final three years in high school within the application period. Mainland China applicants may provide the National College Entrance Examination (NCEE) result and Chemistry result of High School Academic Proficiency Test. Late submission will not be accepted and the University will only consider applicants' other choices.
- ③ Applicants who wish to apply for Bachelor of Arts in Foreign Language Studies or Bachelor of Food and Beverage Management must declare their major on the application. The University will make final admission decision based on applicants' intended major and actual situations. All admitted students must register in the program and major that are specified on the acceptance letter.
- ④ The above programs are full-time. Details about the course syllabus and study plan can be checked from the respective faculties on [MUST website](#).
- ⑤ The following programs are NOT open to non-local applicants this academic year:
 - **Hong Kong, Taiwan, Malaysian and Mainland China Applicants:** Bachelor of Biomedicine.
 - **Other International Applicants:** Bachelor of Laws, Bachelor of Traditional Chinese Medicine, Bachelor of Biomedicine, Bachelor of Pharmacy in Chinese Medicine, Bachelor of Pharmacy, Bachelor of Arts in Art Design, Bachelor of Fine Arts in Digital Media, Bachelor in Film and Television Production, Bachelor in Acting, Bachelor of Food and Nutritional Sciences, Bachelor of Arts in Foreign Language Studies-Portuguese and Bachelor of Arts in Foreign Language Studies-Spanish.

3 Application Fee

- 3.1 Applicants must pay the application fee within the application period. Application will become effective only after the applicant submits online application in the Online Application System (OAS) and pays the application fee. Applicants are deemed to give up their applications if they fail to pay the fee within the application period and the University will not process such applications any further.

If "Payment Processing" is still shown, please choose other payment methods in order to meet the due date as late payment will not be accepted.

- 3.5 Applicants who pay the application fee at the Accounts Office Service Counter, Banco Nacional Ultramarino (BNU), or via Online Payment Gateway will NOT be required to upload the receipt to the OAS. Applicants who use other payments method will be required to upload payment receipts (e.g. Application for Funds Transfers) for verification.

4 Ways of Admission

Applicants can apply for undergraduate programs through “Admission through Written Examination” or “Direct Admission” according to their qualifications. Application can be submitted only once per academic year.

4.1 Admission through Written Examination

4.1.1 Admission Requirements

Applicants can apply with us through “Admission through Written Examination” if they meet any one of the following requirements:

Remarks:

- (1) Applicants must upload the required documents listed above to the OAS.

- (3) Applicants must be holding valid identification documents.
- (4) Non-local applicants must be aware that the identification documents held must comply with the Law of Macao to apply for stay permit for study purpose in Macao. For details, please [refer to](#) the Residence and Stay Affairs Department of Macao Public Security Police Force’s website.
- (5) Holders of Macao SAR Non-Permanent Resident Identity Card are fully responsible on their own for all the consequences resulting from the change of their resident status during the study period.
- (6) Mainland China Students currently studying in Hong Kong with temporary Hong Kong Identification card are not eligible for admission.

4.1.2 Admission Examination Arrangements

- 4.1.2.1 Except for those who have been approved of examination exemption, applicants who apply for admission through Written Examination are required to sit for the Joint Admission Examination (Languages and Mathematics).

- 4.1.2.4 Applicants of Bachelor of Arts in Art Design must attend Program-specific Examination (Fine Art Examination). Applicants of Bachelor in Acting must attend the Program-specific Examination (Interview & Audition). Details about the arrangement of Program-specific Examination will be notified by Faculty of Humanities and Arts.

4.1.3 Exemption from Examination

4.1.3.1 Applicants with the following qualifications may apply for exemption from taking Chinese, English and Mathematics examinations:

Subject for Exemption	Requirement
Chinese	Applicants without basic education in Chinese Language during the last three years of study in secondary education. <small>Remarks 1 & 2</small>
English	International English Language Testing System (IELTS): Band 6.0 or above Test of English as a Foreign Language (TOEFL): Paper-based test: 550 or above; Computer-based test: 213 or above; Internet-based test: 79 or above.
Mathematics	Awarded the second prize or above in the high school group in the Mathematical Olympiad competition.

Remarks:

- (1) According to the requirements of the programs, applicants whose choices include the programs of Bachelor of Laws, Bachelor of Traditional Chinese Medicine, Bachelor of Biomedicine, Bachelor of Pharmacy in Chinese Medicine, Bachelor of Pharmacy, Bachelor of Food and Nutritional Sciences or Bachelor of Arts in Art Design are required to take Chinese examination.
- (2) Applicants who have been exempted from the Chinese examination may have to take the aptitude test in Chinese. They also need to take Chinese language or culture related courses taught in English for substitution of the Chinese courses prescribed in the study plan of admitted program.

4.1.3.2 Application for Exemption:

Apart from completing the online application procedures, applicants who want to apply for exemption from admission examinations are also required to submit **by person** the following documents to the Academic Registry before application deadline *:

- The completed form "Application for admission examination exemption" (Downloaded from the [University Website > Admission > Undergraduate Programs > General Information > Forms Download](#))
- Original and copy of academic certification documents corresponding to the qualifications for exemption
- Original and copy of valid identification documents

*Recommended students who need to take the Joint Admission Examination can apply for exemption within the period of Jan 5 – 20, 2021.

4.1.3.3 Applicants will be informed of the application result via e-mail no later than one week before the examination. Applicants are required to sit for the examination of subjects that are not approved for exemption.

4.1.3.4 Apart from admission through written examination, Hong Kong, Taiwan and International students can also apply for our undergraduate programs through Direct Admission.

4.1.4 Bonus schemes for Delta Asia Quiz

4.1.4.1 Application Qualification: application with the following qualifications may apply for "Bonus Scheme for Written Examination":

- Applicants who have been awarded First/Second/Third prize of Delta Asia Quiz during the last three years of secondary school study.

4.1.4.2 Application method: Apart from completing the online application procedures, applicants of the "Bonus Scheme for Written Examination" are also required to submit the following documents to Academic Registry before the application deadline:

- Written application by the applicants: it should include the application number, name, and a valid telephone number of the applicants and indicates as "Application for the Bonus Scheme for Written Examination".
- copy of the certificate/qualification of awards.
- copy of valid identification document.

4.1.4.3 Application Result:

Upon verification and assessment by the University, applicants may receive a bonus of 30 to 50 marks added to the results of Languages and Mathematics Admission Examinations which are required for the programs applied. (For example, if an applicant is required to take three examination subjects and 40 marks is to be granted upon verification and assessment, he/she will receive this bonus mark for each of the three subjects, adding a total of 120 bonus marks towards the total score.)

4.1.5 Release and Rechecking of JAE Result

- 4.1.5.1 The JAE results will be released through Online Application System in designated period.
- 4.1.5.2 If applicants have any queries about JAE results, they can apply for score rechecking before the prescribed deadline after the release of JAE results. No late application will be accepted.

The minimum GPA for applying is 3.0 (with 4.0 being the highest).
- (8) If the public exam result is not yet announced before the application deadline, applicants may apply by the predicted grades issued by their high school/college/institution.

4.2.1.2 Hong Kong, Taiwan and International applicants without the qualifications listed in point [4.2.1.1](#) can also apply for Direct Admission if they have graduated from Form 6, Senior Middle Three, Grade 12 or equivalent / above.

4.2.2 Notes for Direct Admission

- 4.2.2.1 Applicants to Bachelor in Acting must attend Interview & Audition. Details about the arrangement of interview will be notified by Faculty of Humanities and Arts separately.
- 4.2.2.2 Applicants to Bachelor of Arts in Art Design must attend Fine Art examination. Details about the arrangement of Fine Art Examination will be notified by Faculty of Humanities and Arts separately. For applicants who have public examinations' results in Art subject as mentioned above can be exempted from the Fine Art Examination.
- 4.2.2.3 Mainland China applicants who apply for Bachelor in Film & Television Production need to attend interview if necessary. Details of the interview will be announced by the Faculty to applicants.

6 Acceptance

6.1 Selection of qualified candidates is based on following aspects:

- All documentary proofs that are uploaded to the OAS, including educational qualifications, results of public examinations, extracurricular activities awards, certificates of social services or artistic skills, etc.
- Results from interviews/ program-specific examination/admission examinations, admission requirements and quotas of each program.
- Applicants' priority of choices.

If applicants fail to meet the program requirements for the 1st choice, the 2nd choice will be considered, then the 3rd and the 4th accordingly. If none of these program requirements is met and they have chosen to accept any designated program, the University will consider whether they can be admitted to other programs.

6.2 The University will not consider the program if applicants are absent in the program-specific examination. The University will only consider their other choices.

6.3 Applicants will be notified by e-mail or SMS informing them to check the admission results on the [OAS](#).

6.4 Admitted applicants* can download the Acceptance letter, Debit Note for tuition fee and other acceptance documents from the [OAS](#)>Download Acceptance Documents page after receiving the e-mail or SMS notice sent by the University. Documents will not be sent by post. If original documents are needed to apply for student visa, please contact Academic Registry immediately.

* Applicants recommended by high schools in Macao will get the Acceptance letter, Debit Note for tuition fee and other acceptance documents by e-mail.

6.5 The admission result is subject to the written Acceptance Letter.

6.6 Some admitted students who have substandard performance in JAE/Admission Examination and Placement Tests may have to take relevant Basic Supplementary Courses, such as Basic Chinese, Basic English and Basic Mathematics. 7 Admission Procedures

7.3 Health Examination:

7.5 In-person Registration: All new students have to register in-person in Late August.

7.6 Students who fail to complete the online registration and in-person registration at MUST campus within the specified period will be deemed as giving up admission eligibility. All fees paid will not be refunded, transferred or retained.

7.7 Class commencement date: September 1.

10 Credit Transfer

Generally, students who have completed courses in a higher education program in other universities or in other higher education institutions which are recognized by the University can apply to the respective Faculty Office for credit transfer before the commencement of classes. Transferred credits normally cannot exceed third of the total credits required for graduation. Credit transfer for all relevant courses in the whole program should be submitted in one application. Please refer to the New Student Handbook sent out with the Acceptance Letter or enquire the respective Faculty Office for details.

11 Cancellation of Admission

The University will cancel a student's eligibility for admission when he or she:

- 11.1 does not possess the qualification for admission;
- 11.2 is being dishonest (e.g. providing information which is incomplete, incorrect or untrue);
- 11.3 submits falsifying documents (e.g. forged certificates or testimonials);
- 11.4 fails to pay fees or other related charges;
- 11.5 does not complete all the registration procedures;
- 11.6 fails to complete the Medical Examination or to submit the Health Examination Report or is diagnosed to be unfit for study in the Report;
- 11.7 fails to submit the required documents, or fail to provide the original copies of the documents as required for verification;
- 11.8 is resolved to be ineligible for admission by the University for other reasons.

For students whose admission is cancelled, all documents submitted will not be returned and payment made will not be refunded, transferred or retained. The University also reserves the rights to refuse future applications from such students.

12 Cancellation of Program

- 12.1 The University reserves the rights to revoke any program/major or suspend enrolling students.
- 12.2 The University reserves the right of not offering certain program/major as a result of insufficient enrollment.
- 12.3 All fees (except application fee) paid will be refunded if the University is not offering the program/major under concern.
