A Special Reminder for the application for "Special Authorisation of Stay" for Non-resident Students

To all Non-resident Students:

Student Affairs Office has accomplished conducting Newly Enrolled Students to apply for "Special Authorisation of Stay" on November 23, and the application procedures were entirely completed, aside from a few students have not attended for their application.

This is to kindly remind all Non-resident Students

- Non-resident Students who are studying in Macau, shall apply for "Special Authorisation of Stay" within a specified time period after their first entry, otherwise interested persons shall confront themselves with overstaying. Repeated violators will be considered to be illegal immigrants, who will be deported and interdicted from entry to Macau within two years.
- Currently Enrolled Students¹ who are able to extend their application of the 2019/2020 academic year, are required to bring along with the necessary documents and head for Stay Subdivision of the Residence and Stay Affairs Department for renewal of Authorisation. The specific date of "Special Authorisation of Stay" should be pursuant to the validity date of Exit of "Exit-Entry Permit for Travelling to and from Hong Kong and Macau (Type D- Stay endorsement)" students possess. Provided that the date of "Special Authorisation of Stay" is granted to December 31, persons shall head for Stay Subdivision of the Residence and Stay Affairs Department for renewal of Authorisation before December 31.
