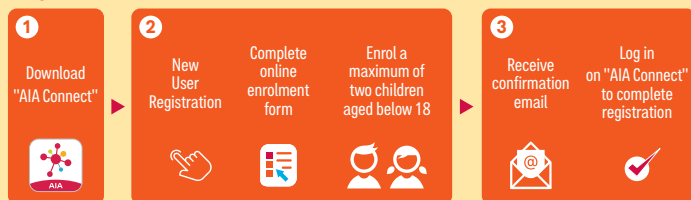

## Terms & Conditions for "Free COVID-19 Cover for Hong Kong and Macau Citizens and AIA Customers"

<b>B. Definition</b>	In this Terms & Conditions, the following words and expressions shall have the following meanings unless the context requires otherwise: -								
1. "AIA", "AIA Hong Kong & Macau", "the Company", "we", "us" or "our"	refers to AIA International Limited (a company incorporated in Bermuda with limited liability).								
2. "Date of Enrolment"	means the date which the enrolment of this Scheme is completed through the mobile application "AIA Connect" within the Promotion Period and confirmed in writing by the Company.								
3. "Date of Registration as "AIA Connect" user"	means the date which the registration as "AIA Connect" user is completed through the mobile application "AIA Connect" within the Promotion Period.								
4. "Diagnosis" or "Diagnosed"	means the definitive Diagnosis made by a Registered Medical Practitioner as defined below, based upon specific condition(s) referred to in the definition of the condition, illness or disease concerned or, in the absence of such specific condition(s), based upon radiological, clinical, histological or laboratory evidence of the relevant condition, illness or disease acceptable to the Company. Such Diagnosis must be supported by the Company's Medical Director who may base his opinion on the medical evidence submitted by the Eligible Person and/or any additional evidence he may require.								
5. "Hospital"	means a lawfully operated institution licensed as a hospital for the care and treatment of injured or ill persons which provides facilities for Diagnosis, major surgery and 24-hour nursing service and is not primarily a rest or convalescent home, or similar establishment, or other than incidentally, a place for treatment alcoholics or drug addicts.								
6. "Immediate Family Member"	refers to a person's legal spouse, child (natural, step or adopted); sibling; sibling-in-law; parent; parent-in-law; grandparent; grandchild; legal guardian or step-parent.								
7. "Independent Person"	means a person other than (a) Eligible Person; (b) an Immediate Family Member of the Eligible Person; (c) a business partner of the Eligible Person; (d) the employer or employee of the Eligible Person; (e) an insurance agent of the Company; or (f) an insurance intermediary or representative of the Eligible Person.								
8. "Eligible Person"	means a person: i. who (a) is not a policyowner nor insured of any AIA insurance policy(ies); and (b) is not an insured member and an insured dependant of AIA group insurance policies (include Group Life Insurance and Group Medical Insurance) Within the Promotion Period, if such person has successfully installed "AIA Connect" mobile application and enrolled the Scheme, a confirmation email will be sent to the person. We will only accept enrolment of up to 2 Eligible Child(ren) provided by the Eligible Person.	means the child(ren) of the Eligible Person who is/are aged below 18 at the Date of Registration as "AIA Connect" user provided by the Eligible Person, and the child(ren) must be currently residing in the same address as the Eligible Person as at the Date of Registration as "AIA Connect" user. 11. "COVID-19"	means a confirmed case of COVID-19 as defined by the World Health Organization and confirmed by relevant medical report.								
12. "Pre-existing Condition"	means (1) any physical, medical or mental condition or (2) any illness or disease: (a) that existed; (b) that was investigated, Diagnosed, or treated by a Registered Medical Practitioner; (c) for which a Registered Medical Practitioner was consulted; or (d) the signs or symptoms of which commenced, before the commencement of the Coverage Period.								
13. "Quarantine"	means a situation when persons are Isolated by applicable law as amended from time to time and/or "Quarantine" must be publicly announced by the government or other statutory organisations of Hong Kong/ Macau. In addition, "Quarantine" shall only apply to quarantine in which persons who are Diagnosed with or have been, or are likely to have been, exposed to the risk of contracting COVID-19 infection. For the purpose of this Scheme, "Quarantine" shall not apply to the lockdown of the entire or any part of the country or city pursuant to any quarantine order made by the government or other statutory organisations of Hong Kong/ Macau, where all transportations namely air, sea, rail and road traffic coming into or leaving Hong Kong/ Macau are closed on a permanent or periodic basis.	means a situation when persons are Isolated by applicable law as amended from time to time and/or "Quarantine" must be publicly announced by the government or other statutory organisations in the locality. <b>E. General Provisions</b>			
1. Termination Of Scheme	This Scheme shall be automatically terminated on 30 June 2020 (immediately after 23:59).		
2. Limitation Of Benefit	i. the Company shall only be liable to pay per life a one-time diagnosis benefit and/ or one-time compassionate benefit (or death benefit) in respect of any coverage for COVID-19 infection; and ii. Once a claim(s) of diagnosis benefit and/or compassionate benefit (or death benefit) under any coverage for COVID-19 infection is given to the Company, the diagnosis benefit and/or compassionate benefit under the Scheme will no longer apply and will not be payable. iii. If the Eligible Person /Eligible Child(ren) is covered under more than one coverage for COVID-19 Infection provided by the Company, the benefits shall be paid under the coverage with the highest amount.		
3.	If the Eligible Person /Eligible Child(ren) has repeatedly enrolled for this Scheme, the Coverage Period will be determined based on the earliest Date of Enrolment.	If the Eligible Person /Eligible Child(ren) has repeatedly enrolled for this Scheme, the Coverage Period will be determined based on the earliest Date of Registration as "AIA Connect" user.	
4. Notice Of Claim	Written notice of claim must be given to the Company after the Diagnosis. In the event of Hospital confinement or death of the Eligible Person /Eligible Child(ren), notice in writing must be given to the Company. Failure to give notice shall not invalidate any claim if it shall be shown not to have been reasonably possible to give such notice and that notice was given as soon as reasonably possible.

Proof Of Diagnosis or Death	Designated forms furnished by the Company (Part 1 of Medical Claim form for Diagnosis Benefit and Death Claim form for Compassionate Benefit) <ul style="list-style-type: none"> <li>• Hong Kong identity card / Macau identity card (as applicable)</li> <li>• Proof of relationship (as applicable)</li> <li>• Proof of address (as applicable)</li> <li>• Travel records (as applicable)</li> <li>• "Diagnosis Benefit": A proof of Diagnosis and Hospital confinement documents</li> <li>• "Compassionate Benefit": A proof of Diagnosis and death certificate</li> </ul> The above lists out the basic required documents only. The Company may require additional document to process the claim.		
6. To Whom Benefits Are Paid	Diagnosis benefit of Eligible Person and Eligible Children, and Compassionate benefit of Eligible Children payable under this Scheme will be paid to the Eligible Person if he/she is alive, otherwise to his/her estate. Compassionate benefit of Eligible Person payable under this Scheme will be paid to the Eligible Person's estate. Payment of the Compassionate benefit and all other benefits payable under this Scheme to the above person(s) in the manner pursuant to this clause shall be deemed a good and full discharge of the Company's obligations under this Scheme. Any payment in connection with this Scheme will be subject to applicable law and AIA's standard screening procedures to be conducted at the time of claim.
