Professional Diploma in Cultural Management (PDCM)

Course Introduction 課程簡介

The demand for professional practitioners in the cultural industry of Macau and Hong Kong has been rapidly increasing due to the direction of China government's decision to increase the soft power of China. The success of cultural organizations counts on practitioners, who should be equipped with knowledge of cultural concepts, a critical mind and an awareness of local and global cultural events. Experience and knowledge of risk, marketing and program management would not be less.

This diploma would be organized by MUST, accredited by Academy of Professional Certification (APC), and endorsed by The Institute of Crisis & Risk Management (ICRM), ISO31000 Risk Management and ISO17024 Standard.

隨著香港及澳門文化及創意產業的發展,對藝術行政及文化管理人員的需求亦日益增加。成功的專業文化管理人士, 應具備文化藝術的概念和知識,批判性獨立思維。市場營銷,風險和項目管理的技術知識亦不能少。本學院的顧問、 教授及管理專業團隊,邀請業界資深人士,共同推出為有志從事藝術行政、文化管理工作之人士提供的專業課程。

本學院重點放在如何實現一個藝術活動、內容結合案例分析、實地考察、小組討論、嘉賓分享、項目演練等多種授課 模式,提升學員的專業認知、欣賞、分析、發展、創意、製作、實務及管理的能力,開拓學員從事專業管理及創意文 化發展之機會,爲需要管理文化藝術活動的學員提供一個專業文憑,並参與實務製作及分享。

Learning Objectives 教學目標

The programme aims to:

- enhance and broaden participants' professional knowledge and practice on contemporary art and cultural management for operating cultural events and exhibitions;

- provide participants the understanding of principles and strategic functions of company governance, project management, risk management, marketing techniques, and financial controls for cultural development and operation management;

- enable participants to understand a variety of specialization in art & culture management such as investor and financial relations, employees and artist communications, operation issues, and crisis management;

- enable participants' professional ability to becoming effective cultural manager in cope with the direction of Macau, Hong Kong and national demanding requirements.

Course Outline 課程大綱

Programme Structure

The programme consists of three modules and two real-life group projects:

<u>Module I</u>

<u>認知、欣賞</u> Appreciation

向學生講解藝術文化的各個領域,比對中西藝術和文化形式;培養獨立思考,不故意擁排古今中外藝術,涵蓋藝術行政管理人員所需要的專業知識。

- Compare and contrast the art and cultural Form of Hong Kong, Macau, China, East and West;
- Essential characters of high culture (opera, ballet, fine art etc.) and
- Mass culture (popular TV, music and film etc.)
- Visual art (Chinese Ink painting, watercolor, oil painting skills overview)
- Heritage symbols of Macau and Hong Kong
- Site visits, group discussions, guests seminar

<u>Module II</u>

分析、發展 Analysis and Business Development

向學生講解藝術文化管理的各個方面範疇,涵蓋藝術行政管理人員所需要的知識和專業領域。將使用案例研究的方法,以確保學生能了解面臨的管理方法,幫助當前和未來的藝術行政管理人員,研究策略和持續的決策。

- persons from any disciplines or experiences who wish to broaden or change their careers to the field of art administration and cultural management.

- (a) Form 5 or equivalent with English and Chinese proficient;
- (b) Professional certification holders or equivalent with 2 years of working experiences in various industries and;

Submit an article on "Self-introduction & reasons in enrolling this programme" within 200 words either in English or Chinese when submitting their enrolment form.
